

- §551.082 School Children; School District Employees; Disciplinary Matter of Complaint
- §551.082.1 Personally Identifiable Information about Public School Student
- §551.083 Regarding Consultation With Representative of Employee Group
- §551.084 Investigation; Exclusion of Witness From Hearing
- §551.087 Deliberation Regarding Economic Development Negotiations

Should any final action, final decision, or final vote be required in the opinion of the School Board with regard to any matter considered in such closed or executive meeting or sessions, then the final decision or final vote shall be either:

- (a) in the open meeting covered by the Notice upon the reconvening of the Public meeting; or
