CALL TO ORDER:

The meeting was called to order by Joni Horton at 12:05 p.m.

APPROVAL OF MINUTES:

Pam Pigman made a motion to approve the minutes of the June 15, 2016 meeting as submitted. Alex Armstrong seconded the motion and the motion was approved unanimously.

- CHA received an "A" –Superior, rating from TEA in Fiscal Accountability. CHA received 98 of 100 points.

FISCAL REPORT

Review of 2015-2016 Fiscal results through July 31, 2016

For the eleven months ended July 31, 2016, revenue was \$4,053,246 which was (\$23,546) less than budget. TEA funding was \$41,000 lower than budgeted due to low attendance. Federal Funds for breakfast/lunch was \$7,000 less than budgeted.

For the eleven months ended July 31, 2016, expenditures were \$4,032,934 which was \$7,000 less than budget. Higher than expected staff tuition reimbursement, retirement contributions, and care of grounds expenses were offset by lower than budgeted professional fees and unemployment taxes.

Review and approval of 2015-2016 final budget (amendment #2)

As required by the TEA, 2015-2016 budget amendment #2 was presented by Renee Permann, CFO. Budget amendment #2 shows an \$11,000 reduction in total revenue which reflects an \$18,000 increase in donations, offset by \$42,000 decrease in FSP/TEA funds, and a \$10,000 increase in Title I and Child Nutrition Program Funds. Budget amendment #2 shows a \$10,000 decrease in expenses from a variety of sources. Budget amendment #2 projects total revenue and expenditures of \$4,412,899 resulting in a balance budget.

Patty Potter made a motion to accept the 2015-2016 final budget, including amendments. Pam Pigman seconded the motion and the motion was passed unanimously.

Approval of 2016-2017 Budget

Renee Permann, CFO, presented the 2016-2017 Chapel Hill Academy budget for fiscal year 2016-2017. Revenue budgeted to be \$4,066,085 and expenditures are budgeted to be \$4,065,717 resulting in a \$348 surplus. This budget is based on 512 students with 97% attendance, and 49 full-time staff. Following review and discussion, Patty Potter made a motion to accept the 2016-2017 Chapel Hill Academy budget as presented. Beth Rivers seconded the motion and the motion was approved unanimously.
