These TEA approved evaluation systems must be used to qualify for additional funds to incentivize teaching excellence; and is a tool to measure campus leadership performance for

the TIP. Alex Armstrong made a motion to approve using the T-TESS and T-PESS systems. Pam Pigman seconded the motion and the motion was approved unanimously.

# **Fiscal Report**

Todd Tudor, Finance Director, reviewed the FY19 Audit Charter School section. There were no significant findings or single audit. The auditors issued an unmodified opinion, the highest available. Alex Armstrong made a motion to accept the FY19 audit as presented. Belvia Moody seconded the motion and the motion passed unanimously.

Financial statements dated December 31, 2019 were reviewed. Investment value as of December 31, 2019 was reviewed. The requested rent valuation report was reviewed with no action recommended at this time.

### 2019-2020 School Year

Audrey Alloway, Principal, reported on student enrollment and attendance. Robert Ramirez has been conducting tardy and truancy hearings at the main office with the result of 26/30 families maintaining compliance.

The Wellness policy has been revised to include current titles and address other minor changes. A Wellness Plan was added as required by the Texas Department of Agriculture. Alex Armstrong made a motion to approve the Wellness policy as presented. Pam Pigman seconded the motion and the motion was approved unanimously.
